The first Regional Conference had been called and was held almost simultaneously with granting of the charter.</p> <p>Territory assigned to the new Region was the states of Alabama, Florida, Georgia, Kentucky, Mississippi and Tennessee. Subsequently, the State of Kentucky was moved into Midwestern Region in 1957 and the eastern part of Tennessee was moved into South Atlantic Region. Puerto Rico was also added to Southern Region in 1978. The Bahamas was added to the region in March, 2012.</p>
